Information about the collection and processing of your personal data

Below, we have provided you with information about how we collect personal data when you use our website. Storage Period

As far as legal, in particular commercial and tax retention periods are to be observed, the storage period for certain data can be up to 10 years. Otherwise the data will be automatically deleted from the server.

Use of cookies

In order to make visiting our website attractive and also to enable the use of certain functions for you, we use so-called cookies on various pages. These are small text files that are stored on your device. Some of the cookies we use are deleted again after the end of the browser session, i.e. after you close your browser (so-called session cookies). Other cookies, however, remain on your end device and enable us or our partner companies to recognize your browser the next time you visit (persistent cookies). You can set your browser so that you are informed about the setting of cookies and thus decide individually whether to accept them or exclude the acceptance of cookies for certain cases or in general. If you do not accept cookies, the functionality of my website may be restricted.
